### **OSC Agenda**

• Avni Patel opened the OSC Meeting with a safety message and highlighted the meeting agenda.

### **OSC Meeting Minutes and Highlights**

• The March 20, 2025 OSC Meeting Minutes and Highlights were reviewed and approved.

### **2025 Press Release**

• Rich Wodyka reported that the 2025 Press Release was published to the media by Jeff Brooks the Duke PR rep on April 4, 2025. The other companies PR reps proceeded to publish the 2025 Press release to their respective media contacts as well. Rich noted that he posted the 2025 Press Release on the CTPC website. Rich thanked the companies PR reps for assisting in the development and publishing the 2025 Press Release

### 2025 Study Activities and Scope Update

- Rich Wodyka led the OSC review and discussion of the 2025 CTPC Study Scope. Joe Mason highlighted the NCEMC proposed changes and rearrangement of the Scope document. After discussion, it was agreed that Rich would update the Scope document based on the OSC review and send out a clean version of the updated document for OSC approval via an email vote. Once the OSC approval is received, then Rich will send out the Final Draft of the 2025 Study Scope document to the TAG for their review and post the document on the CTPC website. The deadline to receive TAG feedback on the Final Draft of the 2025 Study Scope will be by the end of the day on April 30th.
- Avni Patel then led the OSC discussion on the schedule for the TAG Assumptions meeting to review the 2025 Study Scope. After discussion, it was agreed that the TAG Assumptions meeting would held on May 5th starting at 1:30 pm to 2:30 pm. The OSC then discussed the material that would be presented at the TAG Assumptions meeting. After discussion, Joe Mason was selected as the presenter of the 2025 Study Scope material at the upcoming TAG Assumptions meeting.

## Multi Value Strategic Transmission (MVST) Activities

- Brant Werts led the OSC review and discussion on the review of the MVST activities specifically the TAG feedback that was received on the Needs Study spreadsheet results and the Benefit Methodology White Paper. He highlighted various items and discussed potential responses to these items. After the OSC discussion, it was agreed that Brant would prepare a document for the OSC review to provide responses to the TAG feedback. Once the OSC reviews the responses, then it will be decided whether a meeting is necessary to have with the TAG members that submitted the MVST feedback.
- Rich Wodyka raised the question whether he should contact the TAG members that submitted the MVST feedback to see if they have any concern with posting their feedback on the CTPC website and distributing this information to the other TAG members as well. After discussion, the OSC instructed Rich to contact those TAG members to solicit their agreement to post and distribute their MVST feedback.
- Brant reported that the MVST Solution results were not yet ready for OSC review.
   He was not yet able to provide an expected time when the results will be ready for OSC review.
